Inviting type package travel : Travels that a travel operator creates travel plans in advance, and solicits travelers (Ex.: pre-planned package travel)

Order-receiving type package travel : Travels that travel operators creates travel plans at the request of travelers, travelersからの依頼によりtravel plansを作成するもの (Ex.: 修学旅行)

Arrangement travel : Travel Operatorが、travelersからの依頼により宿泊施設や乗車券等のサービスを手配するもの

Sales on consignment : 他のTravel Operatorが実施するInviting type package travelについて、当該他のTravel Operatorを代理してpackage travel契約を締結するもの
