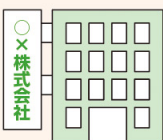

A *Gyoseishoshi Lawyer* can provide thorough support—from preparing a handwritten will to creating a more formal notarial will.

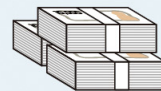


Case 7 I Want to Resolve a Money-Related Dispute
